Will is the Last Will and Testament

of me

Richard Scall of the old Bell Inn Kings Norton in the County of Hereford son of Robert and Sarah late I appoint Alfred Herbert of Redditch in the said County of Hereford (whiche and Thomas Keason of Redditch aforesaid together (hereinafter called "my Executors") to be the Executors and Trustees of this my Will I devise the messuage shop and premises situate at the corner of the Redditch Road and tillage then at Kings Norton aforesaid and here in the occupation of my daughter Caroline Maria Herberts with the appurtenances therunto belonging with and to the use of my said daughter Caroline Maria Herberts her heirs and assigns subject to and charged with the payment to my Trustees within twelve months after my death of the sum of three hundred and fifty pounds I devise and bequeath all the residue and remainder of my real estate and all my personal estate whatsoever and whithersoever (including the said sum of three hundred and fifty pounds charged upon the said hereditaments herebefore specifically devised) with and to the use of my Trustees their heirs Executors and administrators respectively according to the nature or tenure thereof Upon trust that my Trustees shall not call in collect or otherwise convert into money such parts of the premises as shall not consist of ready money and shall out of the moneys so arise pay such call calling in collection and conversion and the ready money of which I shall be possessed at my death pay my funeral and testamentary expenses and debts

And shall stand possessed of the residue of the said moneys when the trusts following
that is to say To be one equal fourth part thereof In trust for my son Charles Station
holder absolutely To be another equal fourth part thereof In trust for my daughter Anne
Rebecca Kimberly absolutely To be another equal fourth part thereof In trust for my said
daughter Caroline Maria Matthews absolutely And as to the remaining one equal fourth
part thereof In trust for the children or any the child of my deceased daughter Ellen
Elizabeth Begg wife being sons or a son have attained or shall attain the age of twenty
one years or being daughters or a daughter have attained or shall attain that age or
marry and if more than one in equal shares I declare that in case a contract
which is now pending for the sale of the Old Mill Inn and premises at Kings Velen
aforesaid now in my occupation shall be carried into execution after my death then
my trustees shall hold the nett purchase money which they as my executors shall
receive for the same upon the same trusts as are hereinbefore declared in respect of
my residuary real estate and personal estate And I declare that my trustees shall be
at liberty to retain out of the share of the said Caroline Maria Matthews or my residuary estate
the said sum of three hundred and fifty pounds charged upon the said settlements
hereinbefore specifically devised to any part thereof the amount so retained to be in satisfaction
or part satisfaction as the case may be of the said sum of three hundred and fifty pounds so
charged as aforesaid And I further declare that if the share of the said Caroline Maria

Mortgages in my ordinary estate shall not be sufficient to pay the said sum^{of} three hundred and fifty pounds so charged on the said hereditaments as aforesaid then the said Lawrence Maria Mortbags shall forthwith pay to my trustees the balance of the said sum of three hundred and fifty pounds and thereupon she shall be entitled to the said hereditaments devised to her as aforesaid freed from the said sum of three hundred and fifty pounds as charged therein as aforesaid And I further declare that the said hereditaments hereinafore specifically devised to the said Lawrence Maria Mortbags subject to the said charge of three hundred and fifty pounds shall be free and discharged from any mortgage or mortgages created by deed therein by me in my lifetime I empower my trustees in their discretion to sell by private treaty and on such terms as they shall think proper to any one or more of my children who may be desirous of purchasing the same any portion of my real estate hereinafore directed to be sold the price or prices required by my trustees to be such as they in their absolute discretion shall think just and equitable Provided always that if my grandsons William Foster Esq^r and Charles Foster Esq^r or either of them shall not within two years after my death claim their or his shares or share under this my will the shares or share which such grandsons or grandsons would have taken under this my will if they or he had claimed such shares or share within the time aforesaid shall be held by my trustees in trust for the four daughters of my said deceased daughter Ellen Elizabeth Esq^r in equal shares And I declare that my executors and trustees hereinafore appointed
