This is the last Will and Testament

of me

William Charles Gould of The Brook
Tickenham in the county of Worcester Needle
and Fish hook Manufacturer I appoint my
dear wife Frances Elizabeth Webb Gould
and my sons William Foster Gould and
Horace Charles Gould if and when they
respectively shall attain the age of twenty one or
years (hereinafter called " my Trustees ") to be the
Executrix Executors and Trustees of this my
Will And I direct that upon each of my said
sons attaining the age of twenty one years the
trust property shall be transferred to and vested
in him jointly with the other Trustees or trustee
for the time being of this my Will And I
declare that all trust powers and authorities
hereinafter vested in my Trustees shall devolve
upon and be exercisable by the survivors or
survivor of them and the executors or
administrators of such survivor or other the trustees
or trustee for the time being of this my Will
I bequeath all the furniture and household
effects in and about my usual place of residence at
my death (except money and securities for money)
unto my said wife absolutely I devise and



bequeath all my real and personal estate whatsoever (except what I otherwise dispose of by this my Will or any codicil hereto) unto and to the use of my Trustees their heirs executors and administrators respectively according to the nature and tenure thereof Upon trust that my Trustees shall (subject to the directions hereinafter contained with respect to my business) sell call in collect or otherwise convert into money the same or such part thereof as shall not consist of ready money And shall with and out of the moneys & produced by such sale calling in collection and conversion and with and out of the ready & money of which I shall be possessed at my death pay my funeral and testamentary expenses and debts And shall invest the residue of the said moneys in the names or under the legal control of my Trustees in any investments for the time being authorized by law for the investment of trust moneys And may vary such investments at discretion And shall pay the income of the said residuary moneys and investments to my said wife during her life And after her death shall hold the said residuary moneys and investments and the income thereof In trust for all my children or any my child who being sons or a son shall have attained or shall attain the age of twenty one



years or being daughters or a daughter shall have attained or shall attain that age or shall have married or shall marry and if more than one in equal shares
And with respect to the business of a Needle and Fish Hook Manufacturer now carried on by me at Feckenham aforesaid under the styles or firms of "George Webb & Sons" and "W. W. Gould & Sons" or otherwise or any other business in which I may be engaged at my decease I empower my Trustees to continue the same for so long as they shall think fit or to discontinue or sell the same at any time and to wind up the affairs thereof with liberty for my Trustees if and so long as they shall continue the business to employ therein the whole or any part of the capital which shall be employed therein at my decease and also such further part (if any) of my estate as they shall think proper and with liberty also to employ managers agents and clerks and also to admit any person or persons as a partner or partners with them in the business and generally to act in the conduct of the said business as they shall in their absolute discretion think fit without being answerable for any loss arising thereby And (subject to the provision hereinbefore contained as to the said business) I authorize my Trustees to postpone the sale and conversion of my estate or any part thereof for so long as they shall think fit And I declare that the rents profits and income of my estate for the time being remaining unsold and

unconverted (including the profits of the said business while carried on by my Trustees) shall be paid and applied to the person or persons and in the manner to whom and in which the income of the proceeds of such sale and conversion would for the time being be payable or applicable under this my Will if such sale and conversion had been actually made *in* witness whereof I the said William Charles Gould have to this my Will set my hand this twelfth day of September one thousand eight hundred and ninety three _____ William Charles Gould _____
