

And it is hereby certified that an Affidavit for Inland Revenue has been delivered wherein it is shewn that the gross value of the personal estate of the said deceased within the United Kingdom (exclusive of what the said deceased may have been possessed of or entitled to as a Trustee and not beneficially) amounts to *£9*. and that it appears from a receipt signed by an Inland Revenue officer on the said affidavit that *£11.12.0* for Estate duty and interest thereon has been paid the duty being charged at the rate of *£2* per cent.

This is the last Will and Testament

_____ of me _____

George Robinson of Inkberrow in the parish of Inkberrow in the county of Worcester retired brick works Manager I hereby revoke all former Wills and Testamentary dispositions made by me I appoint my daughter Georgiana Caroline Webb the wife of Richard William Webb of Redditch in the county of Worcester clerk in Her Majesty's Post Office and the said Richard William Webb (hereinafter called "my Trustees") to be the Executrix and Executor and Trustees of this my Will I bequeath unto my son George Thomas Robinson my gold watch writing desk photographic apparatus and Alzroy Barometer absolutely I bequeath the sum of forty pounds to my said daughter Georgiana Caroline Webb my said son George Thomas Robinson my daughter Amanda Therese Ryder and the children of my deceased son Victor Ernest Robinson in equal fourth shares absolutely so that each of my said children shall take one fourth thereof and the children of my said deceased son the remaining fourth thereof the same legacy to be paid out of the share of my daughter Fanny Augusta Robinson in my residuary estate as hereinafter

mentioned I devise and bequeath all my real and personal estate (except what I otherwise dispose of by this my will or any bodieil hereto) unto my Trustees Upon trust that my Trustees shall sell call in and convert into money the same or such part thereof as shall not consist of money and shall with and out of the moneys produced by such sale calling in and conversion and with and out of my ready money pay my funeral and testamentary expenses and debts And shall stand possessed of the residue of the said moneys Upon the trusts following that is to say As to one fifth part thereof In trust for my said son George Thomas Robinson absolutely As to one other fifth part thereof In trust for my said daughter Georgiana Caroline Webb absolutely as her separate property As to one other fifth part thereof In trust for my daughter Amanda Therese Ryder absolutely as her separate property As to one other fifth part thereof In trust for the children of my deceased son Victor Ernest Robinson who being male shall attain the age of twenty one years or being female shall attain that age or shall marry under that age and if more than one in equal shares And as to the remaining one fifth part thereof In

trust to pay thereout the aforesaid Legacy of forty pounds and then to pay the residue of such remaining one fifth part or share to my said daughter Fanny Augusta Robinson absolutely. And I declare that I have deducted the said sum of forty pounds from the share of my said daughter Fanny Augusta Robinson as she received that sum from me whilst I was living at Alvechurch. And with respect to the expectant shares of my infant grandchildren I direct my Trustees to invest the same in any investments authorised by law for trust funds with power to vary the investments thereof from time to time at their discretion. And I empower my Trustees in their discretion to raise any part not exceeding one moiety of the presumptive share of any infant grandchild and to apply the same for his or her advancement or benefit as my Trustees shall think fit. ~~My wife's~~ wholeof I have hereunto set my hand this fifth day of December one thousand eight hundred and ninety four.
