the Sole Executor named in and appointed by the said Will reserving nevertheless Power to revoke these
Letters of Administration and to grant probate of the said Will to the said John Strimpton the said
Edward Klingender having been first duly sworn that the said deceased died on the seventh day of July
one thousand eight hundred and eighty And that he will well and truly collect and administer according to
law the property lands hereditaments goods chattels and credits of the said deceased which shall come to
his power control hands or possession that he will exhibit and deposit in the Office of the Master
in Equity a true and perfect inventory of the property lands and hereditaments goods chattels and
credits of the said deceased which shall come to his hands or possession within three Calendar Months from
the date of the Order granting Administration And also will exhibit and deposit a true and just
account of his administration of the said Estate as to his receipts and disbursements and as to what
portion is retained by him and what portion remains uncollected in the said office of the Master in Equity within
fifteen calendar months from the date of the said order And that he believes the real and personal property
of the said deceased in the Colony of Victoria is under the value of One hundred and forty pounds —
